I hereby confirm my booking for one service during the 2009 breeding season to the Stallion _____

Such confirmation is based upon our agreement as follows:

1. Payment due from mare owner
 - a) Service fee shall be \$ _____. Booking fee of **\$250.00**
Booking deposit is deductible from the Stallion Service fee.
Balance \$ _____ payable before mare leaves the ranch after breeding.
 - b) Boarding fees shall be \$10.00 per day wet, \$8.00 dry.
 - c) Mare owner is responsible for payment of Veterinary bills before mare leaves the ranch.
2. Health and conditions of mare:
 - a) mare owner agrees that mare shall be healthy and in sound breeding condition and the stallion owner may require certification by a veterinarian before mare be bred. It is understood that the stallion owner or manager may have their own veterinarian check mare for normal breeding condition.
 - b) mare owner will be consulted before any extensive veterinary treatment is given if it should be necessary.
 - c) If shod, mares to be bred must have their hind shoes removed, preferable before mare arrives at the breeding facility.
 - d) Mare to be current on vaccinations and de-wormer within 2-3 weeks before arrival.
3. Health and conditions of Stallion:
 - a) stallion should be sold, die or become unfit for service before mare is bred, this contract shall become null and void, then the booking fee shall be returned.
4. Accident or injury to mare, foal, or stallion:
 - a) Owner or manager of stallion and ranch and their representatives agree to act with all due diligence and to exercise every precaution in the breeding and care of mare and her foal. However, the owners of the ranch or stallion shall not be liable or responsible for disease, accident or injury to mare or foal unless caused by their negligence. The Owner of the mare shall not be liable or responsible for any accident of injury to the stallion or for disease.
5. Live foal guarantee:
 - a) Stallion owner agrees to guarantee a live foal (that stands and nurses without assistance after foaling.) This guarantee applies only if stallion owner is notified in writing within one week following death of foal, which notice must be accompanied by a statement by a license veterinarian.
 - b) In the case of a mare aborting the fetus in earlier pregnancy, a statement by a licensed veterinarian stating the mare is not in foal and that it was not caused by negligence of the mare owner shall be required.
6. Breeding certificate:
 - a) Breeding certificate shall only be issued when service fee is paid in full and mare has been vet checked in foal.
7. Other Agreements: Shipped semen will be available with a limit of two shipments per mare
